

**Treasurer's Report January 2017**

**Monthly Financial Analysis**

January 2017 had expenditures of \$44,256.19 and revenues of \$69,307.99 for a monthly net of positive **\$25,051.80**. The year to date balance is also a positive **\$25,051.80**.

Our proposed budget for 2017 is \$634,000.00. Expenditures in January are in line with the proposed budget and spending plan.

Session elders must approve all church expenditures. This includes expenditures using church bank accounts, credit card accounts, and reimbursements. Elders need to approve expenditures in advance and reimbursements prior to submitting them to the bookkeeper. Elders cannot approve their personal expenditures or reimbursements. Requests for transactions requiring special processing by a signer on our accounts needs to be sent to the bookkeeper and myself. 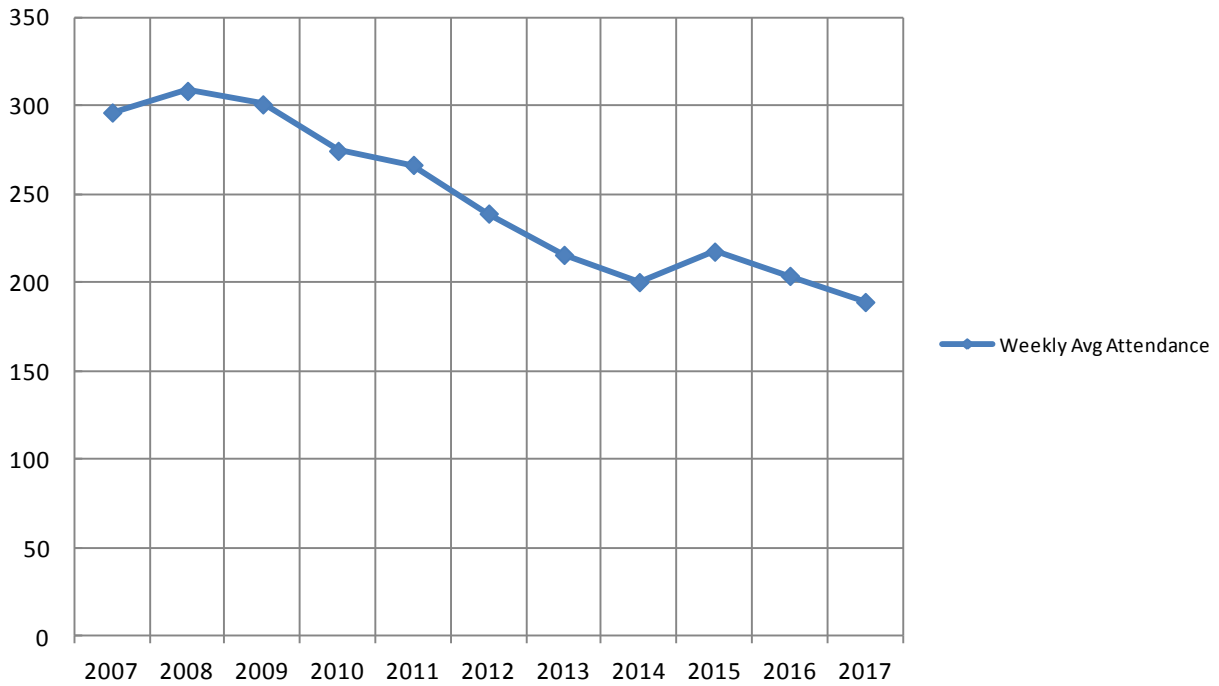

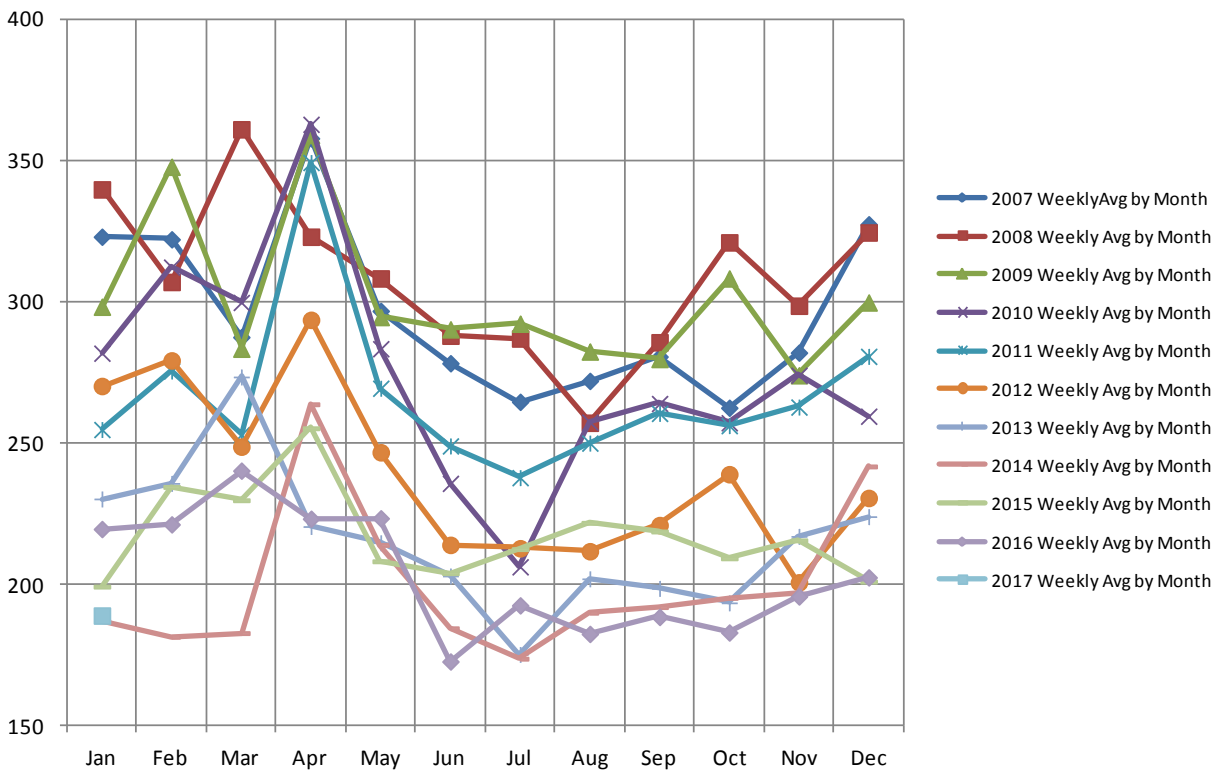
