

Treasurer's Report June 2019

Monthly Financial Analysis

June 2019 had expenditures of \$53,997.99 and revenues of \$48,616.18 for a monthly net negative of **\$5,381.81**. The year to date balance is **negative \$5,624.03**.

Our approved budget for 2019 is \$608,120.00. The 2019 monthly giving needs to average \$50,676.67 to meet our 2019 budget number. The monthly giving average through May is \$48,060.40. Our spending is behind our plan, we are \$10,073.59 less than budgeted through May, however that assumes a linear spend rate and several expenses are paid quarterly.

The capital campaign balance as of July 18, 2019 is \$101,993.57. Since fall of 2017, we have collected \$315,529.36. We have spent \$213,535.79 on smaller repairs, consultant fees, fellowship roof replacement, sanctuary lights, sanctuary roof repairs, cross cleaning, and many other items.
