Monthly Financial Analysis

March 2019 had expenditures of \$56,749.97 and revenues of \$52,776.00 for a monthly net negative of **\$3,973.97**. The year to date balance is **negative \$6,343.69**.

Our approved budget for 2019 is \$608,120.00. The 2019 monthly giving needs to average \$50,676.67 to meet our 2019 budget number. Giving has fell short by \$12,338.06 in the first three months to meet that average. However, March was above the monthly giving average.

The capital campaign balance as of March 31, 2109 is \$232,223.55
