Monthly Financial Analysis

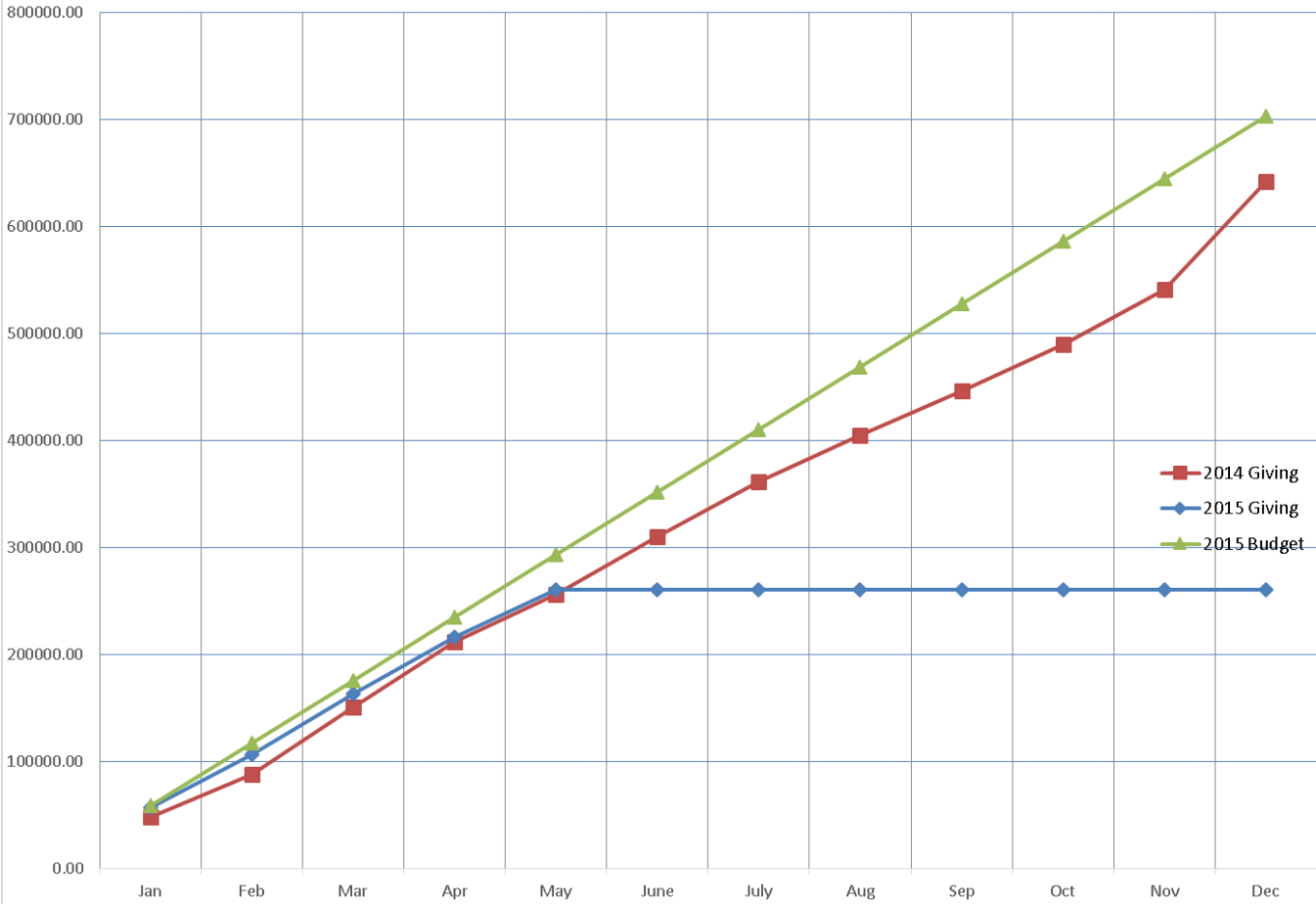
May 2015 had expenditures of \$58294.51 and revenues of \$43770.60 for a monthly net of negative \$14,523.91. With 1/12 of our 2014 roll thru (\$13,000) in, we are negative for the year, \$ 20,679.67. With the total 13,000 roll thru we are \$7679.67 negative for the year. We have positive balance in our bank account because of our designated funds.

May's cost are normal for a given month, however May's giving was the lowest this year. Giving year to date is \$3669.08 over this time in 2014. Our giving has to increase to reach our 2015 budget of \$703225.00

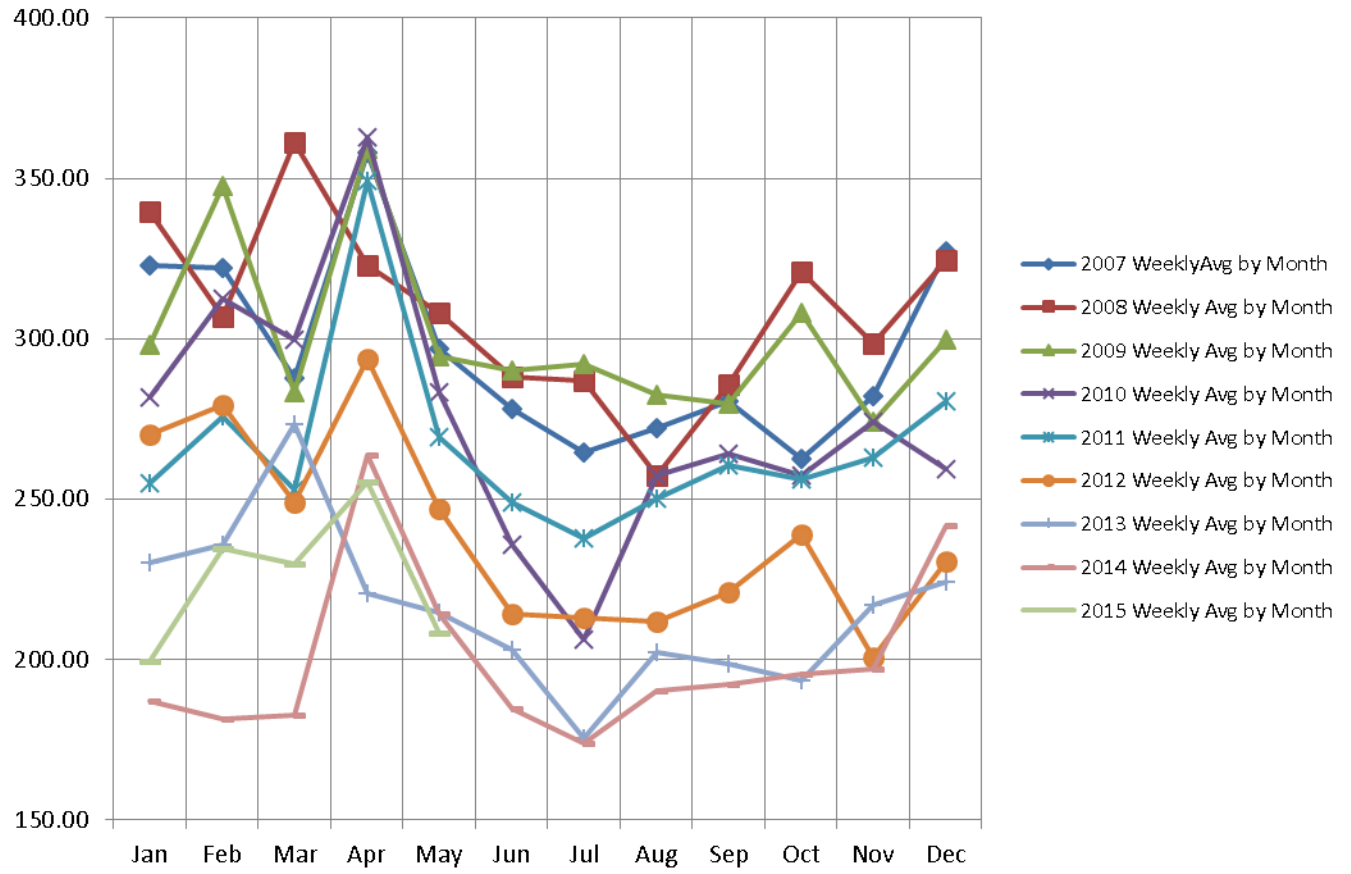

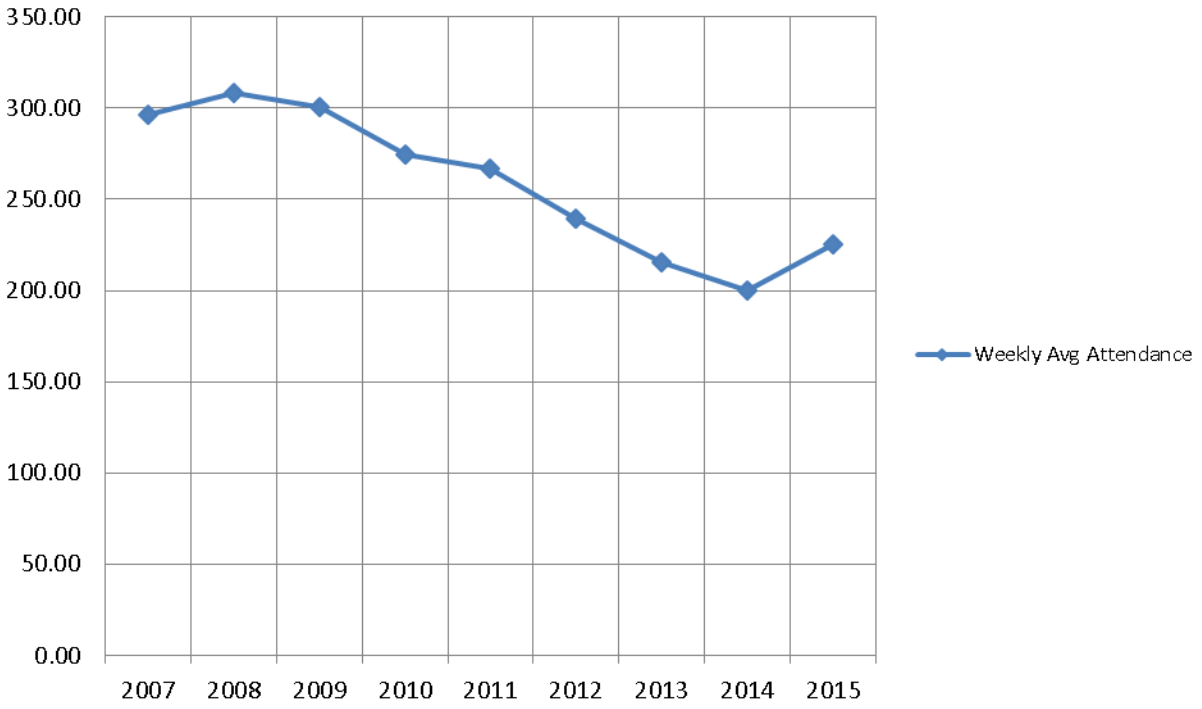
2015 vs 2014 Cumulative Giving by Month
