As per the 2023 annual operating budget, monthly contributions and expenses are targeted at \$47,913.33 for a balanced budget – total budget for 2023 is \$574,960.00 in both categories.

Contributions in July were 116.5% of plan; a surprisingly positive number for a summer month as these tend to be low contribution months. Expenditures were 73.4% of plan resulting in a positive balance for July and the year.

The report detailing mission specific accounts through the end of July 2023 is included.

The end of July balance of the capital account is \$12,465.02.

Session approved funding plan for upgrade and refurbishment of the organ. A very positive response from the congregation has totaled \$66,660.00 in contributions to the fund as of August 17<sup>th</sup>. We have processed the first two payments for the organ refurbishment totaling \$50,000.00.

After ten years as bookkeeper, Pat Forke resigned. We will miss her diligence to this role. Filling the position is subject of another report from Personnel and Finance.
