

Treasurer's Report December 2020

Monthly Financial Analysis

December 2020 had expenditures of \$49,412.45 and revenues of \$81,681.09 for a monthly net positive of \$32,268.64. The revenues for December reflect an average giving for this time of year. Expenses were slightly lower as we paid some quarterly bills in November due to that month's record giving.

Yearly Financial Analysis

Our year-end balance is positive \$49,634.67. This is due to the reduction in spending that the Finance team and session put in place due to the uncertainty of giving during the COVID-19 pandemic.

Our approved budget for 2020 is \$630,000.00. Ideally we spend that entire budget. In 2020, we spent \$567,520.44. That is \$62,479.56 less than budgeted. The major areas that account for the underspend in 2020 are:

1. Campus Management - \$24,293.26 under budget. Utilities were lower due to less facility use, and maintenance was taken out of capital campaign
2. Mission - \$18,305.75 under budget. Decision to only fund pledge to Presbytery.
3. Worship and Music - \$9,436.22. Due to online services, we did not have the regular special musicians cost and Organ maintenance and tuning were not completed

Those 3 areas totaled \$52,035.23 of the \$62,479.56 less than budgeted amount. The remainder underspend was spread across the budget areas, but the change in worship and operations of WPC due to COVID-19 was the cause.

The total year giving to the operating budget was \$617,155.11, which is \$12,844.89 less than our budget goal. However the giving was enough to fund our staff fully, pay for the campus, insurance, and fund our payments to the Presbytery.

Gifts Outside of the Operating account

In addition to the mission budget set aside in our operating account. WPC collects gifts towards multiple charities and other extra giving throughout the year. (Gifts of Joy, Penecost, and Organ enhancement fund, etc.) That 2020 total was \$63,609.49.

Capital Campaign

The capital campaign balance as of December 31, 2020 is \$68,637.27. The 2020 giving to the fund was \$43,386.27

Total Giving

The giving to the operating account, capital campaign, and designated missions/giving totaled \$724,150.87 in 2020. This number does not reflect donations in kind or material to WPC or our supported missions/institutions.

PPP Loan

Our bank has informed us that our PPP loan was approved by the SBA to a grant. I have an email only, and still awaiting official documentation. The full loan of 78,800 was approved. Those monies are in a designated account in this report.
