As per the 2022 annual operating budget, monthly contributions and expenses are targeted at \$48,483.33 for a balanced budget month-to-month – total budget for 2022 is \$581,800.00 in both categories.

December contributions continued three month strong trend, catching up on mid-year slump in contributions. WPC ended the year at 99.1% of plan. Pledged giving was below that anticipated by 2022 estimate of giving cards; routine but non-pledged giving was strong for the year and sufficient to approximately match the decrease in pledged giving.

December expenses were above plan (as forecasted in the last two reports) due to quarterly insurance payment, contributions to Presbytery mission account and the per capita payments. At year end, expenses were 96.6% of budgeted values.

The report detailing mission specific accounts through the end of 2022 is included. The cumulative balance in these accounts is \$39,333.38. The capital improvement fund balance is \$28,759.45. Details on contributions and expenses are in the attached.

As of today (19th), 82 contributors who have returned their estimate of giving (EoG) cards for 2023. For 2022, we had 95 family units submit an estimate of giving card.
