As per the 2022 annual operating budget, monthly contributions and expenses are targeted at \$48,483.33 for a balanced budget month-to-month – total budget for 2022 is \$581,800.00.

For the month of May, giving exceeded expenses by \$1,659.59 reducing the year-to-date deficit to \$8,417.36 (at end of April, WPC was a little over \$10K in the red).

Four considerations for the year to date (YTD), end of May totals specific to the 2022 operating budget:

- In general, giving is down and expenses have been controlled at below budget
- Expenses have exceeded income by \$8,417.36 (in the red)
- Characterized another way, giving to the operating budget is close to three weeks behind budget, rapidly approaching a month behind in budgeted giving.

A key consideration specific to YTD (as of the end of May) non-operating budget mission giving is the generosity of the congregation!

The typical trend is that giving decreases significantly during the summer months. We will need to pay specific attention to spending through the summer.

As noted, in May, expenses have been controlled very well. YTD, spending for insurance and general maintenance has been above budget. Note that funding for the incredible work completed and planned for general maintenance and improvements to the campus has been a combination of operating budget and capital monies.
