As per the 2022 annual operating budget, monthly contributions and expenses are targeted at \$48,483.33 for a balanced budget month-to-month – total budget for 2022 is \$581,800.00 in both categories.

September contributions continued the strong trend realized through the summer. Giving for the month was approximately \$8,000.00 above budget plan. YTD, giving to the operating budget has exceeded expenses by \$48,994.47.

Expenses in September were above plan primarily driven by the quarterly insurance premium payment. YTD, spending is \$36,000.50 below budget.

Remaining large expenditures for the year:

- Over \$15,500.00 for quarterly insurance payment in December
- \$8,000.00 to satisfy our Presbytery mission giving pledge for 2022
- \$3,600.00 to meet our per capita pledge for 2022.

Please note that we did receive a 25% reduction in the insurance premium for the remainder of the billing cycle - \$8,845.00. We submitted a series of risk assessments to an independent, non-profit specific accreditation group that then recommended the reduction to our insurance carrier.

The new, single page report detailing contributions to WPC in support of missions beyond the operating budget numbers - designated and restricted accounts – is included. I have not received any comments on the report so will continue to report monthly for these accounts.

As of October 18th, we have received \$1,100.00 for the second Ukraine relief initiative; activities for this will continue through November.

Initiatives to improve the facilities using the capital campaign account balance continue. YTD, this account as received \$29,190.00 in contributions and spent \$104,622.27. The balance in the account **as of October 18** is \$33,149.71. Major expenditures, approximately 91% of all spending from this account, to this point in 2022 include

- \$56,154.59 to replace the AC units for the Education Building
- \$23,286.28 to replace and refurbish the windows of the narthex, Fellowship Hall
- \$8,000.00 (approximate) collection of miscellaneous expenses for repair/refurbishment
- \$6,096.00 for bathroom refurbishments

- \$5,233.31 for refrigerator for the kitchen
- \$1,800.00 for roofing contractor
- \$1,620.46 for platforms for the outside seating areas
- \$1,298.00 for chairs, tables, benches for the outside seating areas

Information on 2023 operating budget will come under separate memo. Four committees have submitted 2023 budget targets.
